Monday, February 8, 2021

Virtual meeting (due to coronavirus)

MEETING: Called to order at 7:11pm by President Craig P. No new members present. 20 members present.

SECRETARY'S REPORT: January minutes read by Heather H. Motion to accept report by Joe C. and seconded by Rick M. Motion passed.

RIDES:

- Several rides were canceled due to cold weather and bad road conditions.
- Craig P. did some Zoom polls to see what members are doing for winter exercise. Members shared winter exercise/activity ideas such as bike trainer, virtual Zumba workouts, cross country skiing, etc.).
- **Ride Sheets:** Remember: if group rider is not a CRR member, ride leader MUST get waiver signed or person can't ride with group. Talk to Chris B. with questions, etc.

OLD BUSINESS:

Membership:

- There are 68 CRR members as of Feb. 8, per Craig P. Membership is up compared to this time last year.
- There is usually an increase in membership around May when people start regularly riding outdoors.
- In 2019, our total membership was 104. In 2020, CRR had 84 members in 2020.

BWR:

- Chris B. asked about the new 12-mile "family friendly" route map. Slow Spokes agreed to map out the route (per Craig).
- Kim P. reminded the group that the catering deposit (from 2020 BWR cancellation) is valid through Dec. 31, 2021. If BWR doesn't happen this year, it could possibly be used for the member picnic.

NEW BUSINESS:

Ride with GPS:

- Rick M. shared that their Florida cycling group has a Ride with GPS account that offers a route library for all members. He thought it would be a good idea for CRR members.
- Craig checked into option: it is \$20/per month for CRR to create an account. Members will have access to the CRR group to view any CRR routes or those shared by members in the CRR group. Routes can be downloaded to devices (Garmin, etc.) and more.
- Chris B. said he could upload BWR routes.
- Members in attendance agreed with the idea.
- Craig will create the CRR group and send a note to members. It will be open to CRR dues paid members only, providing another member incentive.

Elections/Board positions:

- Members voted for the board officers via the confidential poll in Zoom. The new board members are:
 - Craig P. – president
 - Linda M. – treasurer
 - Dave J. – secretary

The new board term begins at the March 2021 meeting.
